

This Memorandum of Understanding (MoU) is made on 18th November 2022.

D. Research & Development:

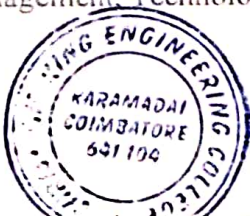
PEBBLES ELECTRONICS will allow students of CKEC for the Research and Development work related to their fields to get an exposure.

The Parties agree that each may publish or advertise the existence of the collaboration between the Parties pursuant to this Memorandum and such collaborative activities undertaken in promotion of this Memorandum provided that prior approval of the other party is first obtained on all such marketing and related materials before publication.


Each party hereby undertakes that it shall respond expeditiously to the other party in relation to such request for approvals required by Clause 13.
