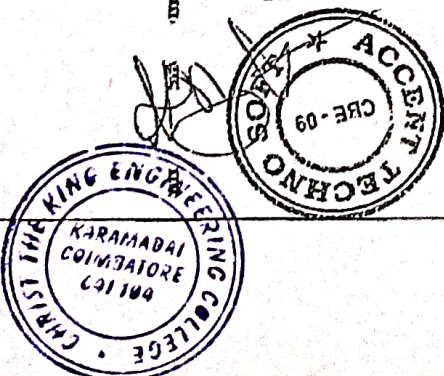


Memorandum of Understanding (MoU)

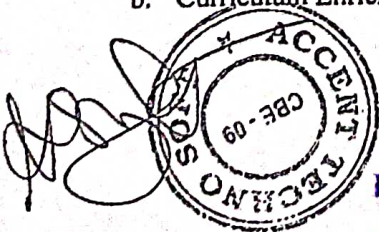

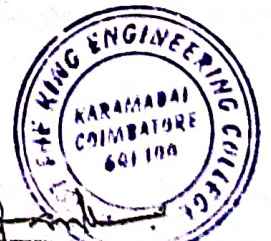

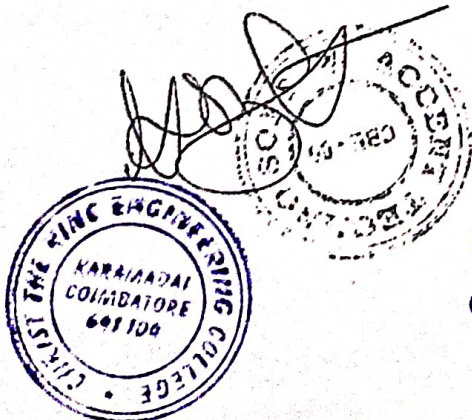
e. Industrial Visits:



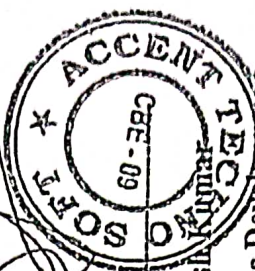
