Further, the Institutions Deemed to be Universities/ Institutions having Accreditation/ Autonomy status shall have to maintain the Faculty: Student ratio as specified in the Approval Process Handbook.
- Strict compliance of Anti-Ragging Regulation, Establishment of Committee for SC/ST, Establishment of Internal Compliant Committee
 (ICC), Establishment of Online Grievance Redressal Mechanism, Barrier Free Built Environment for disabled and elderly persons, Fire
 and Safety Certificate should be maintained as per the provisions made in Approval Process Handbook and AICTE Regulation notified
 from time to time.
