3. This memorandum seeks to give this co-operation a more formal and long-lasting status in order that the two parties may work more effectively together.


### Objectives

6. This Memorandum of Understanding will come into force on the date of its signature by both parties and will be valid for a period of three (3) years from that date. Both parties agree to review this Memorandum of Understanding after three (3) Years following the date of signing and acknowledge that this Memorandum is subject to revision and termination at any time by three months' notice by either party.

The Parties agree that each may publish or advertise the existence of the collaboration between the Parties pursuant to this Memorandum and such collaborative activities undertaken in promotion of this Memorandum provided that prior approval of the other party is first obtained on all such marketing and related materials before publication



8. The official text of this MOU shall be the English language, and any interpretation or construction of this MOU shall be based thereon. If this MOU or any documents or notices relating to it are translated into another language, the English version shall be controlling in the event of discrepancy between the two.
