- This memorandum sets out the understanding of, on the one hand, MILLTRONICS EMATIKS, Coimbatore and Department of Electronics and Communication Engineering & Department of Electrical and Electronics Engineering, CHRIST THE KING ENGINEERING COLLEGE, Coimbatore, Tamil Nadu of the principles that will underlie relations between them.
- 2. This memorandum is a statement of intent and should not be interpreted as a binding agreement. It does not create legal obligations between the parties. It is intended to be binding in honors only. It is established for the mutual benefit of the co-operation between the two parties.

Parties

- 3. MILLTRONICS EMATIKS, registered at the following address: 65C, 1st Floor, Balasubramania Road, KK Pudur, Saibaba Colony, Coimbatore, Tamil Nadu-641 038.
- 4. Department of Electronics and Communication Engineering & Department of Electrical and Electronics Engineering, CHRIST THE KING ENGINEERING COLLEGE, Tamil Nadu (herein after referred to as "CKEC"), registered at the following address: Cecilia Gardens,158/3, Onnipalayam Road, Karamadai, Coimbatore, Tamil Nadu -641 104.

Intent

1. This memorandum seeks to give this co-operation a more formal and long-lasting status in order that the two parties may work more effectively together.

Objectives

- 2. Both parties hereby agree to encourage academic, research co-operation, skill development, internships, joint project proposals and consultancy through development, research, study and training. Specific details of any activity or project under this Memorandum of Understanding will be set forth in a separate agreement.
- 3. It is envisioned that the cooperation will be based on activities mutually agreed between the parties as per the following scope:

A. Industrial Visits:

Based on convenience, MILLTRONICS EMATIKS will allow students of CKEC for 5 industrial visits for a semester towards the benefit of practical exposure.

B. Guest Lecture:

MILLTRONICS EMATIKS will provide guest lecturers to students periodically to get them motivated to become competent and successful entrepreneurs. Vice versa, CKEC will provide classroom and explanatory sessions at its facilities to train / re-train the Employees of MILLTRONICS EMATIKS.

C. Project Work:

MILLTRONICS EMATIKS will allow students of CKEC for live project works, aimed at building confidence and will help them to get prepared for smooth transition from academic to a professional working environment.

D. Research & Development:

MILLTRONICS EMATIKS will allow students of CKEC for the Research and Development work related to their fields to get an exposure.

E. Problem Solving:

When the problem areas or thrust, areas are identified during the course of interaction between CKEC and MILLTRONICS EMATIKS for further research and problem solving, they may use the facilities / resources available mutually.

F. Internships:

MILLTRONICS EMATIKS can provide opportunities and inputs to students of CKEC to undertake internships and field studies to provide inputs in the field of Management, Technology development and Marketing.

G. Curriculum Development:

The experience and expertise of the Managers and Engineers MILLTRONICS EMATIKS will be made available for CKEC in framing the curriculum, so as to suit to the needs of the industry.

H. Studies and Consultancy to the Industry:

The faculty resources and expertise of CKEC, and student assistance could be made use of by MILLTRONICS EMATIKS for undertaking any studies for improvement/ productivity increase in any of its activity segments.

I. Hands on Training:

MILLTRONICS EMATIKS can provide hands on training in the field of embedded system, IoT and PCB design.

Working Arrangements

- 4. In order to progress opportunities for mutual co-operation, it is agreed that there will be meetings at a senior level between the two parties. Other meetings will be arranged at an appropriate level to progress the projects identified for mutualdevelopment. The date and location of meetings have to be mutually agreed between the parties.
- 5. With regards to the envisioned meetings, both parties agree that each party will bear its own costs incurred, including travel, per diem, honoraria and all other cost.
- 6. This Memorandum of Understanding will come into force on the date of its signature by both parties and will be valid for a period of three (3) years from that date. Both parties agree to review this Memorandum of Understanding after three (3) years following the date of signing and acknowledge that this Memorandum is subject to revision and termination at any time by three months' notice by either party.

7. The official text of this MOU shall be the English language, and any interpretation or construction of this MOU shall be based thereon. If this MOU or any documents or notices relating to it are translated into another language, the English version shall be controlling in the event of discrepancy between the two.

8. Under no circumstances, MILLTRONICS EMATIKS is liable to CKEC and viceversa.

9. The disclosure of any confidential/proprietary information between the parties should not be presented in any format, without the approval of others.
