What constitutes Ragging?

Ragging constitutes one or more of any of the following acts.

Ph: +91 91500 76729

- Any conduct by any student or students whether by words spoken or written or by an act which
 has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- Indulging in rowdy or in disciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- 3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- 4. Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

Procedure for filing a complaint

- A written complaint consisting below-mentioned information is required to be filled by the victim or any person.
- b. Anyone can drop the letter to the Principal / Teacher-in-charge office or they can log on to the college website and fill the complaint there.

Disciplinary Procedure

The Anti-Ragging Committee will deal with all disciplinary matters. The Committee shall constantly monitor the behavior of the students. All disciplinary matters will be placed before the Committee, which will hear the matter and take action according to the due process of law.

• The affected student is required to submit an anti-ragging affidavit as per the UGC notification.

• Continuous watch and vigil over ragging by Surendranath Law Collegeand the College will promptly deal with the incidents of ragging brought to its notice.

• The University will summarily punish or reprimand the guilty student, either by itself or by following procedures, administrative or otherwise, by constituting a special Enquiry Committee and put forth its findings or recommendations before the competent authority to take a decision.

Students are encouraged to report any ragging act witnessed or experienced by them to the College administrators, faculty, Anti-Ragging Committee and Grievance Redressal Cell or other any staff member with whom the student may feel comfortable. The College ensures the confidentiality of such a disclosure by the student.

Penalties

Students will be instantly suspended from the college for you a period of one week, if any complaint is made against him. The matter will be placed before the Anti Ragging committee, which will review the incident of ragging and take action according to due process of law. The other penalties are as follows:

- 1. Fine with a public apology. With holding of scholarship or other benefits extended to those involved in ragging.
- 2. Debarring from representation in cultural or sports events, or any other in events for which the student(s) may have been selected.
- 3. Entering the ragging incident on the transfer certificate/ migration certificate of the students which may adversely affect their career.
- 4. Debarring from representation in cultural or sports events, or any other in events for which the student(s) may have been selected.

7. Expulsion from the college.

Ragging and the Legal provisions:

As per the AICTE notification the following punishments can be given to the indulged in ragging

- A student in the act of ragging is or her juniors may be expelled from the college
- He/she maybe banned or the bird from staying in hostel
- Scholarship /stipend and financial grants can be withdrawn or cancelled by the colleges
- He/she may be debarred from appearing in for the examination of the colleges
- He/she may be debarred from taking admission to any other educational institution in the state or even in the entire country.
- He/she may be charge Sheeted and the the court of law may try the accused student.
